To bring you quality product, we must mind the details behind the scenes — and not everyone understands this. The Oregon Association of Nurseries works hard to support our producers so they can do what they do best. We work with the Oregon Department of Agriculture to ensure that buyers get the best and safest products possible. Growing practices are being developed and updated constantly as new issues come up.

Another way we support our growers is by helping them ship their goods to the winter and summer trade shows with the Trucks to Trade Shows program. If you are a grower you may have used this program. If so, you know it makes things easy — just load your pallet, get it to the drop-off site in Oregon, and let the drivers handle the rest.

We also represent Oregon at MANTS (Mid-Atlantic Nursery Trade Show) in Baltimore, Maryland and at Cultivate in Columbus, Ohio. If you are attending either of these shows, we invite you to find our booth, pick up your free copy of our *Nursery Guide* (full of plants, supplies and services), and chat with someone from the OAN staff. They are a great resource.

If you are planning that trip to Oregon, our staff can give you advice and facts about our state and our growers.
